- Participation in any special projects the center might be engaged in
- Participation in advertising outreach programs

**2. Students who participate in this experience will be exposed to the purposeful application of the following student development, career development, counseling and or organizational theories:**

- Identity Development Theories (Racial, Social Class, Sexual, Gender)
- Multicultural Counseling Theories (Sue & Sue, Pedersen, Lee)
- Psychosocial Developmental Theories (Chickering, Erikson)

**3. Student assigned to this site will be able to participate in the following assessment and/or evaluation projects:**

- Evaluation of any special projects
- Program Assistant outreach programs

**4. Students who participate in this experience will be evaluated and provided on-going feedback in the following ways:**

- Weekly meetings with practicum supervisor.
- End – of – semester formal evaluation with practicum supervisor.
- Feedback from selected CC staff members who they work with.

**5. Expectations of the students assigned to this site include:**

- Active participation in CC meetings and activities
